



**WAR DOGS YOUTH FOOTBALL CLUB**

**PARTICIPATION WAIVER AND RELEASE OF LIABILITY**

In consideration of being allowed to participate in any way in the War Dogs Youth Football Club programs, related events, and activities, the undersigned:

**1. Acknowledgment of Risk:**

Acknowledges that participating in sports activities, including the use of weight room facilities, inherently involves risks of physical injury. I understand that these risks cannot be completely eliminated, and I willingly assume them on behalf of my child as a participant.

**2. Weight Room Facility Usage:**

Understands that the use of weight room facilities involves the risk of injury from various causes, including but not limited to, the use or misuse of the equipment, the sudden failure of equipment, or the negligence of others. Agrees to follow all instructions and policies related to the use of the weight room facilities and to immediately report any observed unsafe conditions or equipment to club staff.

**3. Fit for Participation:**

Affirms that the participant is physically fit to engage in football activities, including the use of weight room facilities, and has no medical conditions that would prevent participation in these activities.

**4. Waiver and Release:**

Expressly waives and releases any and all claims, now known or hereafter known, against Brophy College Preparatory or the War Dogs Youth Football Club, its officers, directors, employees, coaches, volunteers, and agents (collectively, "Releasees"), on account of injury, illness, death, or property damage arising out of or attributable to the participant's participation in the club activities, including the use of weight room facilities, whether arising out of the negligence of the Releasees or otherwise.

**5. Indemnification:**

Agrees to protect, indemnify, and hold harmless the War Dogs Youth Football Club, Brophy College Preparatory, and all associated releasees (collectively, the "Releasees") from any and all claims, losses, damages, or costs, including reasonable attorney fees, resulting from the participant's involvement in club activities, including the use of weight room facilities.

**6. Consent for Medical Treatment:**

Authorizes any representative of the War Dogs Youth Football Club to seek, obtain, and approve medical care for the participant as deemed necessary by club staff or team coaches.

**7. Media Release:**

Grants permission for the War Dogs Youth Football Club to take and use photographs, videos, or any other recordings of the participant engaged in club activities for promotional, publicity, or any other purpose.

**8. Acknowledgment of Understanding:**

Affirms that this Waiver and Release of Liability has been read and understood, and it is agreed that it will be binding upon the participant, the participant's parents or guardians, heirs, administrators, executors, and successors.

By signing this document, I understand that I am giving up substantial rights on behalf of the participant and agree to it freely and voluntarily without any inducement.
